# **Cathy Fleury, Agility Trial Chair**

Cathy Fleury has been a member of Fox Valley Dog Training Club since the early to mid-90's. She was training at a private facility in Rockford when she found the club. Cathy paid for the drop-in classes before becoming a member. Sally Compton, who volunteered at the guest table then, suggested she become a member. She told Cathy that she had already guest trained more than the membership costs would be.

She has been on the Board since the early 2000s, starting off as Treasurer before co-chairing with Vera Nyberg as the Agility Trial Chair in late 2000 before taking over the position.

Cathy started doing agility as a way to just play with her dog. It was not an AKC event then. Cathy enjoys competing and training in agility so much that she:

- trains and competes with her own dogs, earning many titles
- competes with dogs trained by her agility students. Cathy started when Vera Nyberg asked her to trial Bitsy



• competes with other's dogs that she trains and trials.

Currently she is competing with 8 to 11 dogs. Cathy said, "Running multiple breeds and sizes gives me a better understanding of the challenges that they bring. They make me a better instructor. I am always looking for solutions that will benefit their training." She loves the teamwork and watching the dogs learn.

Rottweilers are Cathy's breed of choice. Her brother and his wife started with the first Rottweilers in the family. Cathy obtained her first Rott from her sister inlaw, pick of the litter. And she has been "hooked" ever since. Cathy co-breeds with Ronnie Bizer when she is interested in keeping a puppy. Cathy said, "We call ourselves breeders of merit."

In 2018 Cathy placed over 20 titles on her dogs for obedience, rally, tracking and agility. She has traveled to National Rottweiler specialties, the Florida Classic and Agility Invitational. Later this year she will be traveling to Colorado for a specialty. She has been to Texas, Pennsylvania, Missouri, Minnesota, and Maine, all for specialties and to the surrounding states for trials. In fact, Cathy had the first Rottweiler in history to earn the VCD4 title. "Spirit was a blessing," said Cathy. Spirit was her first breed Champion and Tracking Champion. She also had 2 other Rott's that earned their VCD4 title and 3 with the VCD3 title.

Currently Cathy is an instructor at Kanosak Canine

Training. She also belongs to the Greater DeKalb Kennel Club and American Rottweiler Club. She instructs at Kanosak three days a week and has one day of lessons and class with her own dogs.

If that isn't enough, she goes horseback riding a couple times a week at her mother in-law's. Cathy was a bookkeeper for over 30 years, and now works part time in accounting where her husband works. This allows her to show on Fridays or travel for obedience and specialties. This year she is looking forward to the 2019 NAC in Tulsa, National Specialty in CO and hopefully back to Florida for the Classic and Invitational. Cathy is also hoping for some new tracking titles, obedience, rally and agility. Along with trying for a VCD4 title on her dog, Touché. She also has two younger dogs that she added to her pack in 2017 and 2018 to enjoy future endeavors.

Good luck Cathy to the future fun I'm sure you'll have. Thank you for all that you do at FVDTC.

# Membership Meeting Highlights - March 20, 2019

Meeting brought to order at 7:37 p.m.

**Carolyn Pearson (Secretary)** The January Meeting minutes were approved as published. Several items of correspondence were read.

**Carla Tsoris (Second Vice-President)** was not in attendance, but reported that she is working with Barb Misch to host an informative presentation on the different classes the club has to offer and where to go after Puppy class. The tentative date for this presentation is the May 15th Membership Meeting. As an incentive, she will host a drawing for all members who attend. She will provide more information in the near future. She thought that the newer members would find that helpful.

**Phil Nuger (Treasurer)** was not in attendance but he reported that class and membership revenue are down slightly from the previous year. However, class registrations are strong. The difference is most likely a timing issue as to when new class sessions began last year versus this year.

Additionally several expenses are lower, such as the cost of insurance is down 10% and the annual recognition award expense is down slightly. Although it is likely there are still a few invoices to pay and he does not know if members earned fewer awards in 2018 as compared to previous years. The Breakdown expense is up, due to a delayed check request submission.

In general, it is still early in the year and it appears that revenues and expenses are tracking closely to previous years. Therefore, no changes in direction are recommended at this time.

**Will Short (Director of Training)** reported that there are volunteers signed-up until the end of June for the Beginner Novice/Novice run-throughs. Will stated that there are currently six instructors doing the rotation. Additionally, a new session started last week, and he is pleased to report that he has not been made aware of any issues.

**Sue MacPherson (Membership Chairperson)** read a list of five new applicants, who were published in the Waggin' Tales. Sandi Stephenson made a motion to accept the list as published and read. Joyce Conway seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to all new members, especially Brian Bourdeau who was present at the meeting.

**Cathy Fleury (Agility Trial Chairperson)** was not in attendance, however, she reported that the Spring Agility Trial is all set and that a significant number of members signed up to work.

**Candy Ellis (Annual Dinner Chairperson)** reported that the theme for this year's annual dinner is "Take a Bow Wow" as a tribute to our trainers, rather than our pups.
