Membership Meeting Highlights - May 15, 2019

Meeting brought to order at 7:47 p.m.

Carolyn Pearson (Secretary). The March Meeting minutes were approved as published.

Phil Nuger (Treasurer) distributed a copy of the summary YTD financial statement, including a comparison between the same timeframe as 2018. He reported that:

- The club is basically on the same revenue and expense pace as previous years.
- General expense up slightly due to timing of setup/breakdown request for 2018 which were submitted in 2019.
- Agility Trial expense down a little, largely due to a \$1,000 savings for judge's expenses by using a local judge.
- Investment account showing about 10% growth since 60% of our assets were moved to market investments from CDs. (\$90,000 in August, 2017 and \$60,000 in May, 2018)

Will Short (Director of Training) reported that all instructors are set for next session of classes, which start on May 30th. He stated that the rotating instructors for the Novice/Beginner Novice run-throughs are set until the end of June. He will start getting volunteers after checking the calendar. Will reported that the current Advanced Puppy instructors, Angie Schmidt, Sally Boeke and Pat Senne have suggested that the Advanced Puppy class be moved to 6:00 p.m., starting with Session 4, August 8th.

Sue MacPherson (Membership Chairperson) read a list of seven new applicants, who were published in the Waggin' Tales. Colette Ansley-Treonis made a motion to accept the list as published and read. Candy Ellis seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to all new members; none were present at the meeting.

Kristina Pomagier (Public Education Coordinator) was not in attendance and had nothing to report, except for sharing the following wonderful news: According to AKC Rally rankings in Front & Finish:

- Bane is ranked as the second top German Shepherd Dog and seventh in all herding breeds.
- Tessa is ranked as the third top Boxer

Kristina wanted to extend her thanks to all of her friends, supporters and mentors!

Candy Ellis(Annual Dinner Chairperson) reported that the dinner was a success, since she did not hear any negative comments after the dinner. It is the week after Easter, 2020 and after both the Greater DeKalb Kennel Club and Car-Dun-Al shows.

Cris Ballenger (CGC Test Coordinator) reported that all 14 teams who participated in the April 18th CGC Test passed. Cris stated that there were at least 12 volunteers, which was really great because all of the dogs participated in the "out of sight" exercise simultaneously, which saved a quite a bit of time for the test. the agenda for the June 12th Board Meeting.


