OFA Eye Exam

FVDTC will hold an OFA Eye Exam on the evening of Thursday October 3rd, 2019 during regular training, at the Kane County Fairgrounds. Exams will be held between 5:00pm and 9:00pm. This is a fantastic opportunity to get your dog's eyes examined at a greatly reduced fee! Plus it is highly recommended that you get your dog's eyes examined yearly.

Denise M. Lindley DVM of Animal Eye Consultants will be performing the eye exams. The cost is \$35 per dog.

**Please include the preferred time that you would like for your arrival, your dog's name and breed, and your preferred contact information. The exams will be approximately a half hour after your arrival. You need to arrive a half hour before the exam time in order to get eye drops placed in your dog's eyes so they are dilated for the exam, and to fill out paperwork. Bring your dog's AKC registration information the night of exams to make filling out paperwork easier.

Get your reservations and fees in early to get your preferred time slot! There may be a limited number of night-of-testing exams available, at a cost of \$40 per dog. Night of examination spots are not guaranteed.

There will be no refunds of examination fees starting two weeks prior to the examine date.

FVDTC Heart Clinic in November

Fox Valley Dog Training Club is proud to host a heart clinic in conjunction with our November Obedience and Rally Trials. Dr. Heidi Kellihan DVM, DACVIM a Clinical Associate Professor of Cardiology, Board Certified Cardiologist at the University of Wisconsin -Madison will be performing the following heart exams:

- AN AUSCULTATIONS EXAM ALONG WITH A DOPPLER ECHOCARDIOGRAM (an Ultrasound of your dog's heart)
- AUSCULTATIONS EXAM
 (listening to your dogs heart)

WHEN: In conjunction with our trial on Saturday November 16th, 2019 from 8:00 am thru 3:00 pm **WHERE:** At our trial site at The Kane County Fairgrounds

COSTS: Echocardiogram exam, which includes an auscultation exam \$250.00 per dog

Auscultation exam only \$50.00 per dog.

Getting to know Jennifer and Fiona

Board Meeting Highlights - June 12, 2019

Meeting brought to order at 7:38 p.m.

Carolyn Pearson (Secretary). The April Meeting minutes were approved as published.

Bob Boeke (First Vice-President) stated that he had nothing to report. Carolyn reported that we need to find a new break-down individual by the end of July, as Michael Otzwirk will be going away to college. She stated that she has placed a want ad in the consortium that goes to all of the local junior colleges.

Kristina Pomagier (Public Education Coordinator) stated that she is working with Carla Tsoris to participate in Coldwell Banker's 2nd Annual Adopt-A-Pet Event on September 28th.

Pat Senne (Obedience Trial Chairperson) stated that the applications have been submitted to AKC for the 2019 obedience and rally trials. The next part of the process is to submit the judges panel. Carolyn also reported that she is expecting to receive the rental agreement for the fairgrounds for the trial.

Ingrid Hamburger (Tracking Test Chairperson) reported that Kent has done great job preparing for the Tracking Test.

Cathy Fleury (Agility Trial Chairperson) was not in attendance, however Will reported that he had heard that the Sportsplex at 720 N. 17th St., would like us to host our Agility trials there again. He stated that it would be nice to be able to host two-ring trials again; however at the time we were there, the equipment that we were renting was not in the best condition, even then.

Old Business

• Boner's Award Survey Results

During the April Board Meeting, it was agreed that we will conduct a written anonymous survey to determine whether the members found the Boner Award offensive. The following are the results of the survey:

 As the majority of the club members were not offended by the Boner Award, the award will continue with some modification to the nomination process. New Business

Annual Eye Clinic

Wendy announced that we will host another eye clinic on October 3rd at the fairgrounds. The exams will be conducted by Dr. Lindley, from Animal Eye Consultants. • Purchase Additional Rally Sign Stands

Carol Schmidt, a Rally judge during the club's fun matches, requested that the club purchase a second set of rally sign holders to enable multiple signs to be placed at each station for multiple rally class levels. In her request, she stated that she put the extra signs on the floor, but they were difficult for handlers to see them on the floor. She stated that at J&J Dog Supplies, a complete set of 28 sign holders costs \$78.00 plus tax and \$7.00 shipping. Wendy and Carolyn both stated that they spoke to other Rally fun match judges who were comfortable using the gold-picture-holders for any secondary station signs. It was agreed that Carolyn, as the original purchaser, would obtain more signholders after determining how many more are needed.

- Consider Donation Opportunity Addressed During July 2018 Membership Meeting During the July 2018 Membership meeting, Cris Ballenger suggested that we consider a donation opportunity for a non-profit at one of our Fun Match's for a canine-related charity. It was agreed that while it is a nice thought, the raffle was originally started to help offset the expenses of hosting the Obedience and Rally Trials. It was suggested that if Cris Ballenger was interested, she could make arrangements to have a special item that would be raffled during our trial raffle and all proceeds from that item would be donated to the selected charity.

A motion was made, seconded and approved to adjourn the meeting at 8:58 p.m.
