Proposed Membership Changes

The Board of Directors is proposing changes to the membership rules for the club, primarily the addition of a *Junior Member* classification. If you've looked around at the club and at trials, you'll notice that most of us are not quite as young as we used to be, so the Board wants to encourage younger folks to join the sport and the club. Along with the by-law changes, the Board is suggesting that attending 4H be added to the current list of classes that serve as a prerequisite for membership. The exact wording of the by-law changes is to be discussed at the November membership meeting, and voted on during the January meeting.

4.2 Types of Membership

- 4.2.1 The Club shall be composed of Active and Honorary members.
 - 4.2.1.1 Active memberships consists of two three types: training, and non-training and junior.
 - (A) A training membership:
 - consists of all interested members of a family having the same domicile.
 - carries a maximum of two votes and both votes must be present and represented.
 - (B) A non-training membership:
 - consists of all interested members of a family having the same domicile.
 - carries a maximum of two votes and both votes must be present and represented.
 - has all the privileges of the Club with the exception of using the training facilities.
 - has dues of one-half (1/2) of the training membership dues.
 - (C) A junior membership:
 - consists of an individual between the ages of 9 and 18 years.
 - carries a maximum of one vote.
 - has all the privileges of the Club.
 - has dues of one-half (1/2) of the training membership dues.
 - 4.2.1.2 A lifetime membership in Fox Valley Dog Training Club, Inc. will be granted to any members who have been members, in good standing, for 15 consecutive years. Lifetime membership:
 - consists of having all privileges of the Club for life.
 - will consist of two types: training and non-training.
 - training lifetime membership dues will be one-half (1/2) of the training membership dues.
 - non-training lifetime member will not pay any dues.
 - 4.2.1.3 Honorary members are:
 - entitled to all privileges of the Club,
 - not entitled to a vote.
 - exempt from payment of dues
 - confirmed by vote of the Club members present.

The term of an Honorary member shall be one year or for life.

Membership Meeting Highlights - September 11, 2019

Meeting brought to order at 7:38 p.m.

Carolyn Pearson (Secretary). The July Meeting minutes were approved as published.

Bob Boeke (First Vice-President) announced that the annual mat cleaning is scheduled for September 23rd and we need at least 12 volunteers! The sign-up was available at the meeting and will be at training on Thursday.

Pat Senne (Obedience Trial Chairperson) was not in attendance but reported that premium lists are available at training, other local training facilities, other local clubs, on Bob Olsen's webpage and AKC's website.

Sue MacPherson (Membership Chairperson) was not in attendance. Carolyn read a list of six new applicants, who were published in the Waggin' Tales. Joyce Conway made a motion to accept the list as published and read. Candy Ellis seconded the motion. The list was approved by all members present, with no one opposed or abstaining. Welcome to all new members, none of whom were present at the meeting.

Ingrid Hamburger (Tracking Test Chairperson) was not in attendance. Joyce Conway reported that the test went very well, seven of the eight entered teams passed.

Kristina Pomagier (Public Education Coordinator) was not in attendance. Wendy reported that Joan Lester and Angie Schmidt have volunteered to participate in a Public Education Event on September 28th from 11:00 am until 2:00 pm at 1212 S. Cathy Fleury (Agility Trial Chairperson) was not in attendance, but reported that starting in 2020, we will be holding three-day Agility Trials. The Friday trial will include the T2B (Time To Beat) and Premier Jumpers classes. The Fall trials occur this weekend.

Jennifer Cornele (Awards Co-Chairperson) reported that the Award Chairs met today briefly.

Cris Ballenger (CGC Test Coordinator) reported that CGC Evaluator, Terri Vaira, passed all eleven registered teams. All dogs were two years old or younger with half the dogs under one year of age! The club earned a total of \$130.00 for the test. A group photograph and candid shots with text were submitted to our Facebook coordinator. A summary of the test night was sent to David Lewis for Waggin' Tales and the web site. Helping with the test were our wonderful volunteers: Carol Hornbeck, Joan Lester, Barbara Mair, Donna Matthews, Ninette Sandefur and Margi Stuessy.

Future Clinics – Wendy Waddick reported that club is hosting the following clinics in the next several months:

- OFA Eye Exam on Thursday October 3rd at the Kane County Fairgrounds. Exams will begin at 5:00 pm and run through approximately 9:00 pm. The pre-paid fee is \$35.00 per dog to reserve your spot.
- Taurine Testing Clinic on Thursday October 8th at the Kane County Fairgrounds. Exams will begin at 6:00pm and until approximately 9:00 pm. Testing the blood for taurine as possible link between grain-free dog foods and a heart condition called dilated cardiomyopathy (DCM). The fee is \$100.00 per dog.
- Canine Heart Clinic on Saturday November 16th from 8:00 am to 3:00 pm at the Kane County Fairgrounds. Two types of exams will be available: Echocardiogram with auscultation (\$250.00) and ausculation alone (\$50.00) per dog.

FVDTC Heart Clinic in November

Fox Valley Dog Training Club is proud to host a heart clinic in conjunction with our November Obedience and Rally Trials. Dr. Heidi Kellihan DVM, DACVIM a Clinical Associate Professor of Cardiology, Board Certified Cardiologist at the University of Wisconsin -Madison will be performing the following heart exams:

- AN AUSCULTATIONS EXAM ALONG WITH A DOPPLER ECHOCARDIOGRAM (an Ultrasound of your dog's heart)
- AUSCULTATIONS EXAM (listening to your dogs heart)

WHEN: In conjunction with our trial on Saturday November 16th, 2019 from 8:00 am thru 3:00 pm WHERE: At our trial site at The Kane County Fairgrounds

COSTS: Echocardiogram exam, which includes an auscultation exam \$250.00 per dog

Auscultation exam only \$50.00 per dog.

This is a great opportunity at a greatly reduced costs!

* EITHER EXAM MUST BE PRE-PAID BEFORE THE DATE OF THE TRIAL *

To reserve your spot for either exam, send your preregistration payment, with checks made payable to Heidi Kellihan DVM, DACVIM. Please include your dog's name and its breed, along with your contact information. Include your email address and phone number. Nancy will set up the time schedule for the exams once the judging schedule is out, she will do her best to work around your ring times. You will need to arrive at least 15 minutes prior to your exam time to fill out any necessary paperwork.
