Board Meeting Highlights – February 12, 2020

Meeting brought to order at 7:45 p.m.

Carolyn Pearson (Secretary). The December Meeting minutes were approved as read.

Cindy Placko (Public Education Coordinator)
reported that she had the honor of representing the
FVDTC along with other members of the club at the
Blue and Gold Ceremony for the Scouts at the
Williamsburg Elementary School in Geneva on March

8, 2020. She was invited in December by Barb Misch, who graciously coordinated this. The other club members in attendance were Francene Andresen, Cheryl Hettinger, Barb Misch and Wendy Waddick.

Each one performed with their dogs as part of the entertainment portion of the ceremony for the Scouts. They told the crowd a little bit about our club, our classes and our dogs. They did demonstrations of rally, obedience, therapy dog work, tricks, and nosework/scentwork. They did a brief demonstration to introduce the crowd to different activities that could be done with their everyday pet. They also explained how we, at the club, work every week to train our dogs and explained how to compete with dogs. There are some great photos of the event taken by Ken Misch.

Barb did a GREAT job coordinating this. Cindy demonstrated the nosework/scentwork portion of the program, which was a good opportunity to represent the club with the other veteran members. The Scouts initially stated that we would have 45 minutes to 1 hour for the presentation. Unfortunately, the carefully planned demonstration was cut short for time, when the Scouts reduced the amount of time for our performance. Cindy reported that everyone worked well individually and together.

Cindy also reported that she and Carla were collaborating on how to make public demonstration events better and more organized in the future. Based on that and participating in the group demonstration, Cindy stated that she would like to get a dedicated list of volunteer members who would be a part of a permanent or rotating performance team that would represent FVDTC as part of public education for the community, dogs, and for dog sports. Phil Nuger (Treasurer) distributed the first quarter FVDTC Financial Statement. It was suggested that we address with the fairgrounds, the rent that we have already paid to but have not been able to hold classes or train due to the COIVD-19 pandemic's state-wide executive order to "shelter in place" in the following ways.

- Perhaps waive the rent we will pay for the November trials (Taffy).
- · Ask about a decrease in rent for the rest of the year.

Taffy Wille (Obedience Trial Chairperson) reported that we received AKC approval for three rally trials and two obedience trials. The last item to determine is the entry fees. Last year, the entry fee structure was \$27.00/\$20.00. Taffy suggested that we consider decreasing the entry fees to \$23.00/\$17.00 to encourage more exhibitors to choose our trials rather than any other close by trials. Unfortunately we are unable to offer any type of crossover discounts between Rally and Obedience. Cathy stated that as an exhibitor with multiple dogs and in multiple classes, she is more apt to pay more attention to the entry fees. Taffy stated that we have a little bit of time before AKC has to make the final approval; she suggested that we discuss it during the next Board Meeting.

She encouraged all Board members to think about the topic and send any thoughts to her via email.

Taffy also reported that, in conjunction with the 2020 trial, we are hosting a CGC Test and a Trick Dog Test. We have the signed contract from Patti Burgess, the Trick Dog Evaluator.
